# Envisioning the Future of Catholic Religious Archives Conference, 2018

## Overview

"Envisioning the Future of Catholic Religious Archives" was a conference sponsored by and held at Boston College from July 11-13, 2018. It was designed to bring leaders of religious communities, archivists, and historians together to seek and identify solutions to the issues that communities, including those coming to completion, are facing in preserving and providing access to their archival legacies.

#### Preserving the Past, Building for the Future Working Paper

The working committee charged with gathering, reflecting upon, and synthesizing the presentations and input from the Boston College Conference "Envisioning the Future of Catholic Religious Archives" released a working paper titled, *Preserving the Past, Building for the Future*.

The paper provides a broad outline of the major areas of concern for Catholic religious leaders, scholars, and archivists who are invested in the long-term preservation and use of these valuable collections as well as suggestions on ways we can move forward together in this important work. The committee recommends that this paper be used as a framework for considering possible solutions to specific challenges faced by each religious community and as a tool to encourage cooperation and collaboration among the three constituencies.

## **Original Program**

In September 2017, the conference planning committee surveyed religious community leaders, archivists, and historians to learn about their thoughts and concerns for the future of Catholic religious archives. Survey results help to shape the conference program.

The goal of the conference was to articulate common needs and to develop strategies and resources for meeting them. The strategy for achieving that goal involved sharing the combined expertise of participants through dialogue aimed at developing a clearer understanding of where we are now and what lies ahead.

It was designed to be a "working" conference. Participants actively engaged with each other, thinking broadly and deeply about issues and practical solutions that communities of various sizes and types can employ going forward.

The conference began with an opening Mass on Wednesday afternoon, July 11, and concluded with lunch on Friday, July 13.

**Session 1: Why Are We Here?** (7:00pm – 8:30pm) Location: Robsham Theater [videorecording]

In this kick-off session, a religious leader, an archivist, and a historian spoke about the concerns, motivations, expectations, and goals that each group held for this conference. This session provided a general introduction to what is common and what is different among their perspectives on archives and outlined the key issues to consider. Goal: Setting the stage

#### Thursday, July 12

**Session 2: What Do We Know?** (8:30am-10:00am) Location: Robsham Theater [videorecording]

Lecture presentation interpreting the results of surveys of religious leaders, archivists, and historians conducted by the conference planning committee in October 2017. What does the data tell us? What are the core values revealed?

#### **Session 3: What Is the Ideal?** (10:30am-12:00pm) Location: Corcoran Commons, Heights Room

Facilitated small group discussions prompting participants to consider their own archival situation in the context of the larger crises affecting Catholic religious communities and their archives and encouraging perspective-sharing and interaction among leaders, archivists and historians.

Goal: Networking, collegiality, team building.

#### Session 4: How Do We Transmit Charism to the Future? (1:30pm-3:00pm)

Location: Robsham Theater [videorecording]

Panel exploring how a community's charism can be expressed through archival sources and the roles that historians, leaders, and archivists can play. How do we determine and preserve what is of enduring value?

### Session 5: How Do I Envision the Future? (3:30pm-5:00pm)

Location: Participants may use conference meeting rooms or return to residence hall rooms

Individual, two-person or small group options for reflection. Participants were provided with prompts and scenarios to guide their thoughts through selected aspects of the religious archives dilemma with the goal of surfacing practical action steps toward making a positive difference.

#### Session 6: What Are the Options? (8:30am-9:30am)

Location: Robsham Theater [videorecording]

Presentations covered three different choices to manage or transfer religious community archives. The first option, creating a charism-based or collaborative archives, serves as a model for those congregations desiring to continue to manage their archival program. The second and third option are designed for those communities facing completion. Representatives from a diocesan archives and university-related repository will share expertise on the process that can be developed to transfer a collection to another archive.
